In consideration of this Permit granted to me by the City of Independence, Missouri, on my request to enter into or upon its premises or property in general, to-wit specifically to ride with a regular police officer on his patrol to observe the duties of said police officer, the undersigned waives, and does hereby release and discharge the City of Independence, Missouri, it's officers and employees from all liability to the undersigned, his employer, assigns and personal representatives for all loss or damage and any claim or demands therefore, on account of injury or other casualty to the person or property of or in the possession or control of the undersigned caused, whether negligently or otherwise, by any person or persons or by said City of Independence, Missouri, it's officers, agents, employees, licensees, or any of them, while the undersigned and/or such property is in or upon the City of Independence, Missouri premises or property, or specifically, while the undersigned is riding with or in the company of a regular police officer on patrol.

The undersigned further agrees to indemnify and hold harmless the City of Independence, Missouri, its officers and employees, from any and all claims of anyone claiming as a spouse or parent of the undersigned, from any and all claims for expenses, costs, or loss of services from any and all liens or claims, including but not limited to any Worker's Compensation benefits, railroad employment or hospitalization by reasons of any and all injuries or damages to the undersigned while on the premises or property of the City of Independence, Missouri, or specifically, while riding with or in the company of a regular police officer of the City of Independence, Missouri.

The undersigned warrants that no promise or agreement not herein expressed has been made to the undersigned, that in executing this release the undersigned does not rely upon any statement or representation made by the party or parties hereby released, or said parties, undersigned relies solely upon the undersigned's own judgment. The consideration herein expressed is contractual and not a mere matter or recital.

I further agree to abide by all instructions of the police officer(s) and agree to stay in the patrol car at all times unless otherwise instructed.

Citizen and/or civilian ride along's must be dressed appropriately. Professional/Casual business attire is required. Citizens who are not dressed appropriately will not be allowed to participate. Jeans and t-shirts are not acceptable.
